#### INSTRUCTIONS FOR ELECTION OF BOARD OF DIRECTORS

Date of Election: 21/09/2025

As per Bye-Laws No. 33, the election will be held for 13 seats of Directors. Among which 10 seats from General Category, 02 seats from Women and 01 seat from SC/ST category.

- A member should bear with him/her an identity Card issued by the Society or by the Govt. Authority. Without Identity Card a member cannot be participate in the Election Process and also in the working of General Body Meeting.
- 3. Every participant member should bear qualification as per provisions of the Multi-State Co-op. Societies Act, 2002, and rules framed there under and schedule thereof.
- 4. Loan defaulters as on 31/05/2025 will be treated as disqualified for Election and for General Body Meeting.
- 5. The list of members eligible to vote shall be made available at Head Office and all branches of the Society. Candidate may get copy of such list by paying fees of Rs.500/-
- 6. Application for Candidature, Nomination Forms, and application of withdrawal of Candidature is available with the CEO/Secretary at Head Office.
- 7. CEO/Secretary has been authorized to accept the application for candidature, Nomination forms and the application for withdrawal of Candidature.
- 8. While submitting the nomination form, a candidate should remit Election Deposit amount of Rs. 2000/- for General Candidate, Rs. 1000/- for Woman Candidate and Rs. 1000/- for SC/ST Candidate. (as the case may be)
- 9. Candidates contesting under SC/ST category should attach their Valid Cast Certificate to the Nomination Form.
- 10. Two Separate eligible voters should sign as a proposer and a seconder for each Nomination Form. Same persons will not be allowed to sign for proposer or seconder for another Nomination form.
- 11. A Candidate or his proposer or seconder only may attend at the time of scrutiny of Nomination
- 12. Prescribed Nomination Forms with incomplete information, without signature or if received after the prescribed time and date will be rejected.
- 13. Candidate may withdraw his Candidature by notice in writing signed by him and delivered in person or by the person duly authorized by him before the date and time specified in the election program. A notice of withdrawal once given shall irrevocable.
- 14. Members enrolled on or before 23/10/2024 are only allowed to participate in this Election of Board of Directors and in the working of General Body Meeting.
- 15. Candidate may express three symbols of his like. (except those of National or local political parties) The Returning Officer has utter right to allot symbols.
- 16. Election Deposit of the Candidate will be forfeited if, such candidate gets less than 1/10 votes of the total voting of that category.
- 17. Copy of MSCS Act, Rules, Bye-Laws and the Election Schedule is available there with the CEO/Secretary for reference of members.
- 18. CEO/Secretary at Head Office should provide additional information about the election to the members within working hours.
